

XIII Conference of Defense Ministers of the Americas



PREPARATORY MEETING

Mexico City, June 4-6, 2018

The Preparatory Meeting of the XIII CDMA was organized by the Secretariat of the National Defense of Mexico, through a Pro-Tempore Secretariat and took place in the Presidente Intercontinental Hotel, Polanco, Mexico City, on June 4-6, 2018.

I. BACKGROUND

- A. The Conference of Defense Ministers of the Americas (CDMA) is an international multilateral political forum integrated and directed by the Ministers of Defense of the Americas, with the authorization of the government of the respective countries. Additionally, based on Article 2 of the Regulations, it has the main objective to promote reciprocal knowledge, the analysis, the debate, and the exchange of ideas and experiences in the field of Defense and Security.
- B. During the XII CDMA, held in Port-of-Spain, Trinidad and Tobago, on October 2016, the Ministers of Defense agreed, in the "Declaration of Port-of-Spain" to establish five Ad Hoc Working Groups for the 2017-2018 cycle of the Conference in different member countries to discuss fundamental issues for the Hemisphere in matters of:
 - a. Cooperation and Coordination Mechanisms on Search and Rescue.
 - b. The Evolving Role of the Armed Forces on Defense and Security
 - c. Defense Cooperation and Hemispheric Security Policy Emergency Humanitarian Relief
 - d. Role of Defense and Security Forces on Environmental Protection and Climate Resilience
 - e. Progressive inclusion of Gender Perspective as a Cross-Cutting Issue in Defense and Security Policy.

II. Legal Framework

Based on the Conference of Defense Ministers of the Americas' Regulations, it is established that:

- A. The Preparatory Meeting is an assembly type meeting. It should be held at least four months prior to the Conference, with the main objective of approving the Thematic Agenda to be analyzed in the ministerial meeting The Preparatory Meeting is attended by the delegates of Member States with the right to vote.
- B. For purposes of planning its activities, the Preparatory Meeting will have the following basic documents prepared by the Executive Secretariat, The proposed Thematic Agenda for the Conference, tentative proposals for updating the Conference Regulations, the administrative instructions for the Conference, a report on the candidates for host country, and the draft of the proposed Declaration.

- C. The plenary of the Preparatory Meeting will have the authority to define the Draft Thematic Agenda by seeking consensus or by a majority of votes, if necessary. In any case, a limited number of themes should be considered in accordance with the available time at the Conference.
- D. The definitive Thematic Agenda will be recorded in the Minutes of the Preparatory Meeting and disseminated by the Executive Secretariat before the Conference. After the Thematic Agenda is approved, only urgent matters may be added with the affirmative vote of two-thirds of the Member countries.
- E. The Preparatory Meeting, under the chairmanship of the Secretary-General of the Conference, will be organized according to the same criteria established for the Conference of Ministers.

- C. **Activity report of the Pro-Tempore Secretariat.** Group General, Aviator, DEMA, Sergio Sotelo Bustos, Executive Secretary of the XIII CMDA presented the activities report of the XIII CMDA (2017-2018).
- D. **Presentation of conclusions and recommendations of the Ad-Hoc Working Groups.** In order to inform the attending Delegates of the results of the Working Groups held during the XIII CMDA cycle, the Presidents of the Ad-Hoc Groups presented the

- F. Presentation and approval of the thematic agenda for the XIV CMDA. The Executive Secretary presented to the plenary of the Preparatory Meeting, the proposal for the integration of the Thematic Agenda. The Delegates agreed to establish it as follows:
 - a. Organize an Ad-Hoc Working Group that addresses the topics "Cooperation in Humanitarian Assistance and Disaster Relief (HA/DR)" and "Cooperation and

Coordination on Search and Rescue (SAR)" allowing the exchange of experiences and best practices about the participation of Defense Forces and Security regarding environmental protection and climate resilience. This Working Group will be hosted by the Dominican Republic on a date to be defined.

- b. Organize an Ad-Hoc Working Group that continues to address the "Evolution of the Role of the Armed Forces in Defense and Security" that includes cyber-security as a tool for Defense and Security of the Hemisphere as well as the theme of Transnational Organized Crime. This Working Group will be hosted by the United States of America on a date to be defined.
- c. Organize an Ad-Hoc Working Group that continues discussing the theme of the inclusion of Gender Perspective as a cross-cutting issue in the Defense and Security Policies in the hemisphere, with the purpose of reaching gender equality and eradicating any kind of discrimination based on gender in the Defense and Security Forces. This Working Group will be hosted by the Republic of Panama on a date to be defined.
- G. **Report of postulations to host the XIV and the XV CMDA.** Brigade General, DEM David Rivera Medina, General Secretary of the XIII CMDA, invited the attending delegates to inform of their nominations to host the XIV and XV CMDA. The following postulations were presented:
 - a. The Cooperative Republic of Guyana expressed its offer to host the XIV CMDA during the 2019-2020 cycle.
 - b. The Republic of Chile expressed its offer to host the XIV CMDA during the 2019-2020 cycle.
 - c. The Federative Republic of Brazil expressed its offer to host the XV CMDA during the 2021-2022 cycle.
- H. Integration of the style committee for the XIII CMDA and procedure for bilateral meetings. The Delegates for the Preparatory Meeting agreed to integrate the Style Committee for the XIII CMDA as follows:

- K. Assisting delegates from Member States unanimously thanked and congratulated the General-Secretary and the Executive Secretary for the excellent organization and direction of this Preparatory Meeting.
- L. Closing Ceremony Brigade General, DEM, David Rivera Medina, Secretary General of the XIII CMDA, declared officially closed the Preparatory Meeting, thanking for the attendance of the participating Delegations, he then proceed to the signing of this Act.
